1. INTRODUCTION

1.1 Definitions:

- (a) "STPI" means the STPI, Chennai.
- (b) "Bidder" means any registered entity engaging in business such as a proprietorship, partnership, private concern or corporation who participates in this tender and submits its bid.
- (c) "Contractor" means any registered entity engaging in business such as a proprietorship, partnership, private concern or corporation who supplying the goods/services under the contract.
- (d) "Supply" means standards of works mentioned in Section IV, which the Contractor is required to take during the contract period.
- (e) "Price" means the price payable to the Contractor under the purchase order for the full and proper performance of its contractual obligations.

The Bidder is expected to examine all instructions, forms, terms and specifications in the Bid Documents. Failure to furnish all information required as per the Bid Documents or submission of bids not substantially responsive to the Bid Documents in every respect, will be at the bidder's risk, and may result in rejection of the bid.

1.2 CLARIFICATION OF BID DOCUMENTS BY THE CONTRACTOR:

- f) Conditional bids will not be accepted.
- g) More than one bid will not be accepted from one bidder.
- h) All the documents submitted (whether original or photocopy) in the bid must be legible & self attested.

2.2 SITE VISIT or EQUIPMENT CHECKUP:

3. BID PRICES:

- **3.1** The bidder shall quote the basic price and applicable taxes separately. However, if there are any changes in the taxes during the contract period, the extra amount will be paid as per the notification of state/central government whichever is applicable, based on the request from the awarded bidder. The bidder shall quote only transportation & delivery charges against the price schedule in the financial bid. The offer shall be in Indian Rupees only. No foreign exchange will be made available by STPI. Rates shall be quoted in words and figures. The amount to be worked out to whole number.
- 3.2 Prices indicated on the Price Schedule shall be entered in the following manner:

4. **PERIOD OF VALIDITY OF BIDS:**

5. FORMATS AND SIGNING OF BID:

6. LATE BIDS:

7. OPENING OF BIDS BY STPI:

- 13.2 STPI reserves the right to disqualify the Contractor for a suitable period who habitually failed to complete the order. STPI reserves the right to blacklist a bidder for a suitable period in case he/she fails to honour his/her bid without sufficient reasonable grounds.

14. ARBITRATION:

If, a dispute arises out of or in connection with this contract, or in respect of any defined legal relationship associated therewith or derived there from, the parties agree to submit that dispute to arbitration under the Indian Arbitration and Conciliation Act, 1996. The venue of the arbitration shall be at Chennai. The language of the arbitration proceedings shall be in English

SECTION – III

CONDITIONS TO THE BIDDERS

1. GENERAL CONDITIONS:-

- a) **Supply & Delivery of Diesel :** The Supply & Delivery of Diesel will be made by the Supplier in accordance with the terms specified in the tender by the STPI. The delivery of diesel should be completed within 10 hours from the date / time of intimation from the official of STPI or the representative by over phone / fax / email as and when demanded by STPI and the supply shall be made during the normal working hours.
- b) The contractor should accept the Purchase order immediately from the date of issue.

2. Renewal:

The contract will be for a period of one year initially and may be extended for further period of three years by renewal of every year, on the same rates, terms and conditions, subject to satisfactory performance. 3. PAYMENT TERMS:

4. Liquidity Damages:

a) Up to 12 hours from scheduled delivery - 0.5% of order value
b) Every successive hours - 0.5% of order value
c) Maximum - 10% of order value

The Decision of STPI will be final and binding.

6.
